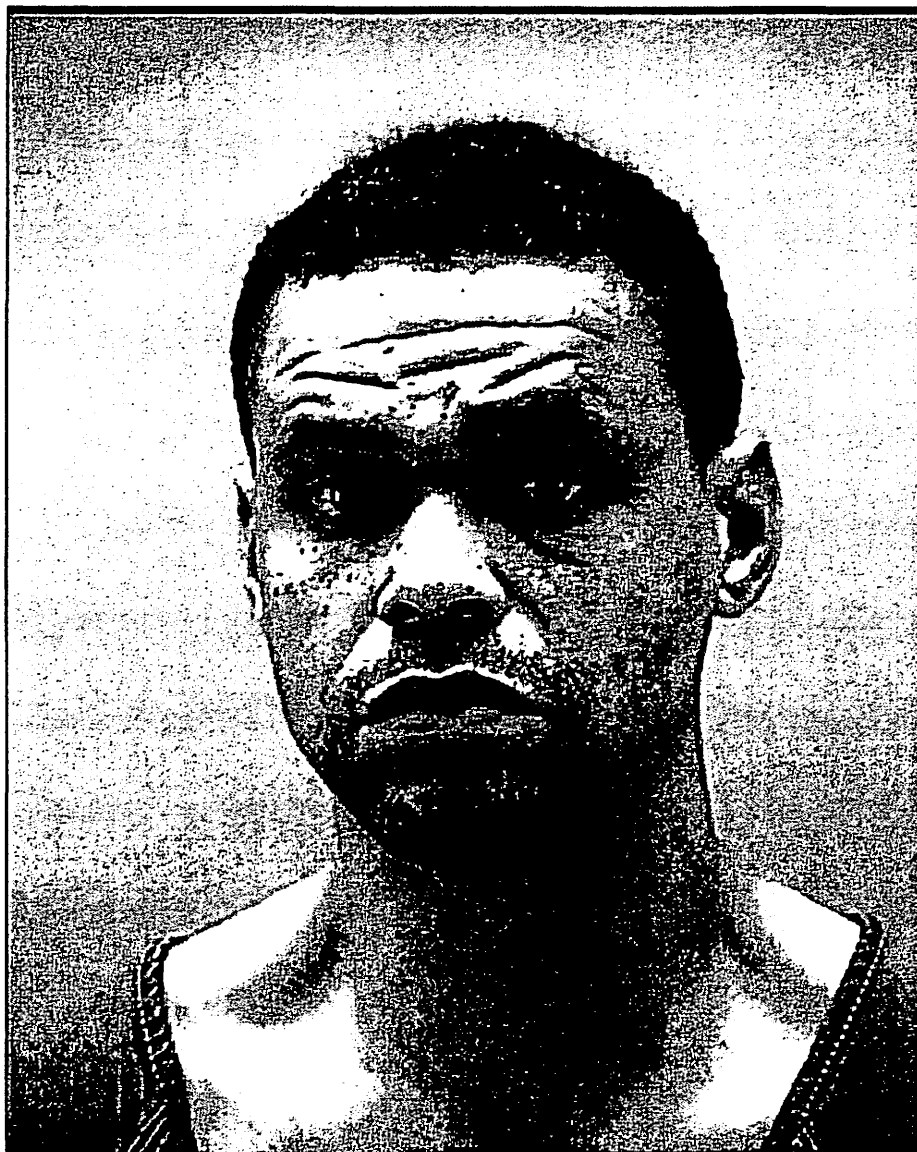

On Wednesday, October 19, 2016, I was assigned as the operations sergeant on third watch. During a routine supervisory walk through of the fourth floor Corrections Officer Zachary Limmer #1160 advised me inmate Charles Alexander Wade (16-20002) wanted to speak with a sergeant. Officer Limmer and I spoke with inmate Wade just outside S-4-2.

Inmate Wade complained about the skin around his left eye burning. Inmate Wade stated he was pepper sprayed twice on October 17, 2016. Report #16-2026 was completed in reference to the incident. I reviewed the report earlier in the watch prior to starting my walks.

I asked inmate Wade if he was provided decontamination after being pepper sprayed. Inmate Wade stated they splashed some water on his face. He also complained about not being able to shower properly because he wasn't provided a towel. I explained to inmate Wade simply rinsing his eyes and face repeatedly with water will decontaminate any remaining pepper spray residue from his face.

Inmate Wade did not like my reply and became uncooperative. He mentioned the recent restraint chair incident involving inmate Swift and Captain Sealey. He asked for a grievance for being pepper sprayed in the chair. I explained under the circumstances, you cannot file a grievance as the officers reacted to your actions at the time.

Inmate Wade stated, "My hands were handcuffed to the chair when they pepper sprayed me." I repeated the decontamination instructions and sent him back into S-4-2. Inmate Wade's statement was not consistent with the jail incident report narratives.

A few minutes later, I requested Nurse Hochwalt to check inmate Wade's eye. She was already on the floor. We responded to S-4-2 to examine him. She provided inmate Wade with an ice pack and told him she would get him skin cream the next day. I took three digital images of inmate Wade's face to show the possible skin burn around his left eye. I printed the images and copied them onto the video file under report #16-2026.

On Monday, October 17, 2016, I was assigned as the first watch booking sergeant for the Montgomery County Jail. At approximately 0439 hours, several corrections and I responded to the sallyport area after the Ohio State Patrol arrived with an uncooperative male, later identified as Inmate Wade, Charles (16-2002). After arriving in the sallyport, I observed two (2) OSP marked patrol vehicles parked one behind the other. We responded to the first OSP vehicle and I immediately observed Inmate Wade quickly lay onto his stomach while handcuffed behind his back within the rear of the patrol vehicle. Inmate Wade then asked, "Are you going to chair me." Corrections Officer Joshua Lightner then spoke to Inmate Wade and successfully had him (Wade) exit the rear of the marked patrol vehicle without incident.

After Inmate Wade exited the marked patrol vehicle, he immediately verbalized his displeasure towards the OSP officers who were within the sallyport area as he was being escorted into the outer-receiving area by correctional staff members. Inmate Wade was then escorted into the inner-receiving area.

After Inmate Wade was escorted into the inner-receiving room, Officer Lightner conducted a search of Inmate Wade. Inmate Wade remained handcuffed as Officer Lightner had him (Wade) kneel on the bench area within the receiving room to remove his (Wade's) shoes. Inmate Wade immediately began to strike his head against the wall behind the bench. To prevent Inmate Wade from hurting himself, Officer Lightner directed him towards the blue mat fastened to an adjacent wall. Inmate Wade then began to strike the blue mat utilizing his head. Inmate Wade was striking the mat with such force, I feared he may harm himself. Therefore, I ordered him placed into the emergency restraint chair. While awaiting for the arrival the emergency restraint chair, I removed the other blue mat on the wall and placed it on the floor of the receiving room. Officer Lightner then directed Inmate Wade onto his stomach area on the top of the blue mat with the assistance of Deputy Benjamin Walters. Deputy Walters assisted keeping Inmate Wade in place by lightly placing his right knee on the upper middle back area of

Inmate Wade, at my request.

Corrections Officer Jamison Kordik placed the emergency restraint chair outside of the receiving room. Inmate Wade was assisted to his feet and escorted to the emergency restraint chair within the pre-book area. Inmate Wade was then sat into the emergency restraint chair. Inmate Wade immediately complained of arm pain from his hands being handcuffed behind his back. I advised Inmate Wade the handcuffs would be removed shortly to place his arms into the soft restraints of the emergency restraint chair. Inmate Wade replied, "Well, we'll see about that won't we sir."

First the corrections officers secured the lap belt and soft ankle restraints on Inmate Wade. The corrections officers were then preparing to remove the handcuffs to place Inmate Wade's arms into the soft restraints of the emergency restraint chair. Inmate Wade began to violently move his upper body back and forth and yelled "Get the fuck off of me!" I was operating the handheld camera at the time and quickly handed it over to Corrections Officer Tiffany Cornely for her to operate. Inmate Wade continued to rapidly move his upper body back and forth within the emergency restraint chair hindering the corrections officers efforts to secure him. I clearly observed the corrections officers were struggling to safely control Inmate Wade. Inmate Wade previously displayed self-harming behavior by striking his head against the walls within receiving. Therefore, to prevent injury to the corrections officers and Inmate Wade, I advised Inmate Wade and the corrections officers I was going to deploy OC spray. I then deployed a burst of OC Spray to the facial area of Inmate Wade. The spray did not have an immediate effect. Inmate Wade, briefly freed his left hand from the corrections officers after it was removed from the handcuffs. Inmate Wade continued to resist corrections officers efforts to secure him within the emergency restraint chair by surrendering his left arm so it could be secured within the emergency restraint chair. I gave Inmate Wade multiple warnings to "Stop resisting," which he ignored. Therefore I deployed a secondary burst of OC spray to the facial area of Inmate Wade which had the desired effect allowing the corrections officers to take hold of his left arm. I then assisted with securing Inmate Wade's left arm with the left wrist soft restraint. The corrections officers secured Inmate Wade's right arm within the right wrist soft restraint.

After Inmate Wade's arms were secured within the emergency restraint chair, he once again began to move his upper body back and forth hindering the corrections officers efforts to secure the shoulder soft restraints. I placed my right forearm on the upper chest area of Inmate Wade and attempted to hold him against the back of the emergency restraint chair. Deputy Walters applied pressure to Inmate Wade's Hypoglossal nerves by utilizing both of his (Walters') hands, placing them underneath of the back of Inmate Wade's jaw, and applying pressure upwards. This had an immediate effect which allowed corrections officers to complete the process of securing Inmate Wade within the emergency restraint chair at approximately 0446 hours.

After Inmate Wade was secured within the emergency restraint chair, he was re-located to MHD131. Nurse Nicole Hochwalt responded and checked the soft restraints on Inmate Wade. Nurse Hochwalt then decontaminated Inmate Wade by flushing his eyes and facial area with water. I took two (2) digital photographs of Inmate Wade which will be attached to this report. Inmate Wade did not have any visible injuries nor did he complain of any as a result of this incident. After Inmate Wade was assessed, all staff members exited the cell.

Corrections Officer Matthew Crum initiated a Montgomery County Jail Special Housing/Restraint Watch Report, which will be attached to this report.

At approximately 0646 hours, I attempted to remove Inmate Wade from the emergency restraint chair. Inmate Wade was yelling, "I'm being denied my constitutional rights." Additionally, Inmate Wade was shouting obscenities towards corrections officers. Therefore due to Inmate Wade's continued disorderly behavior, and for the safety and security of the jail, I ordered him to remain within the emergency restraint chair. Corrections Officer Leslie McGill and Officer Kordik removed Inmate Wade's limbs, one at a time, from the soft restraints and allowed him to stretch them. After Inmate Wade stretched his limbs, Inmate Wade was re-secured within the emergency restraint chair. It is important to note that no SBH personnel was on duty to speak with Inmate Wade.

At approximately 0720 hours, after exhibiting appropriate behavior, I determined Inmate Wade could be removed from the emergency restraint chair. Inmate Wade was re-located to MHD141. The soft restraints were removed from Inmate Wade, other than the soft wrist restraints, securing Inmate Wade's arms. Inmate Wade attempted to rapidly exit the chair by trying to stand up. Inmate Wade was unable to exit the chair and sat back

down. Inmate Wade was allowed a few additional minutes to show calmer behavior. Before the soft wrist restraints were removed, Inmate Wade began to move his head side to side, stretching his neck, as if preparing for a physical confrontation. Inmate Wade then asked, "This would not be a good decision would it?" Inmate Wade was advised to show appropriate behavior so he could be released from the emergency restraint chair. Inmate Wade vowed not to cause staff members any more issues, therefore the soft wrist restraints were loosened and Inmate Wade was removed from the emergency restraint chair and housed within MHD141 without further incident at approximately 0724 hours. I advised Sergeant Chapman to have second watch SBH personnel speak with Inmate Wade.

I archived all Divar video surveillance footage and handheld camera footage of the incident, which will be attached to this report. Additionally, I completed a MCSO Use of Force Report which will be attached to this report.

On Monday, October 17, 2016, I was assigned as the jail transportation deputy on first watch.

At approximately 0445 hours Inmate Charles Wade (16-20002) was brought into the jail by Ohio State Troopers as an uncooperative male. Inmate Wade showed several signs of aggressive behavior by cursing at the Trooper and head butting the outer receiving door while being escorted into receiving. Once inside receiving, Inmate Wade continued to head butt the wall and refused to listen to verbal commands. Inmate Wade was then assisted to the ground by Corrections Officer Lightner and myself.

Sergeant Eversole ordered Inmate Wade be placed into the emergency restraint chair due to him showing signs of wanting to hurt himself.

As Inmate Wade was being secured in the emergency restraint chair, he began to flail his body back and forth and again refused to listen to verbal commands. Inmate Wade was pepper sprayed and again continued flailing around in the emergency restraint chair by moving his upper body rapidly back and forth. Therefore, I applied pressure to Inmate Wade's hypoglossal nerve, utilizing both of my hands by placing them under the back portion of Inmate Wade's jaw and pulling upwards. This was done in order to control Inmate Wade's head and upper body from moving while other corrections officers finished applying the soft restrains on him. I assisted by securing the left ankle soft restraint.

A use of force report will accompany this report.

On Monday, October 17, 2016, I was assigned as the receiving officer on first watch. At approximately 0439 hours, Ohio State Patrol Officer Davis arrived with an uncooperative male subject, later identified as Wade, Charles (16-20002).

As I entered the sallyport and opened the rear door of the cruiser in which Inmate Wade was secured, I asked him to exit the cruiser. Inmate Wade willingly exited the cruiser and began making threats towards the arresting officer. As we approached outer receiving, he (Wade) forcefully rammed his head into the door in which separates the sallyport and outer receiving. I instructed Inmate Wade to relax and stop hitting his head to prevent any injuries to his person. I then entered the receiving vestibule and as I began to search his person, Inmate Wade was being cooperative and answering my questions. Once I instructed him to place his knees on the bench to remove his socks, Inmate Wade began to forcefully ram his head into the receiving wall. I then assisted Inmate

Wade back to the blue mat, at which point, Inmate Wade began to forcefully ram his head into the blue mat which was fastened to the wall. For Inmate Wade's safety, I instructed officers to remove the blue mat from the wall so I could escort him to the ground and prevent any self-inflicted injuries.

Inmate Wade was placed on the ground and the search of his person was completed. Sergeant Eversole then ordered officers to restrain Inmate Wade in the emergency restraint chair due to the likelihood of him hurting himself in a cell. I assisted Inmate Wade to his feet, and escorted him to the restraint chair. Inmate Wade sat in the chair and began to repeatedly state, "Why do y'all white people do this to niggers?" I assisted with securing the lap belt soft restraint. As I attempted to remove his left wrist from the handcuffs, Inmate Wade began to forcefully thrash his body around while yelling, "Ouch! Get the fuck off my hands!" Sergeant Eversole deployed a burst of OC spray to the facial area of Inmate Wade. The left wrist was removed from the handcuffs, at which point Inmate Wade pulled his left arm away from corrections officers. Sergeant Eversole then deployed a second burst of OC spray to the facial area of Inmate Wade. The second burst had the desired effect and Inmate Wade's left arm was taken hold of and placed in the left soft wrist restraint. Inmate Wade continued to aggressively resist and, while controlling his right wrist with the handcuffs, I placed it in the right soft wrist restraint. I then tightened the wrist restraint and removed the handcuffs from his right wrist. Officers finished securing Inmate Wade and he was housed in MHD 131.
