THE GRAND JURORS of the County of Montgomery, in the name, and by the authority of the State of Ohio, upon their oaths do find and present that: **JENNIFER SELHORST AKA: JENNIFER WOODWARD**, *on or about AUGUST 16, 2016 in the County of Montgomery, aforesaid, and State of Ohio*, with purpose to defraud, or knowing that she was facilitating a fraud, did utter, or possess with purpose to utter, any writing, to-wit: CHECK(S), which she knew to have been forged; contrary to the form of the statute (in violation of Section 2913.31(A)(3) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

SECOND COUNT:

AND the grand jurors of this County, in the name and by the authority of the State of Ohio, upon their oaths, do find and present that: **JENNIFER SELHORST AKA: JENNIFER WOODWARD** *on or about JANUARY 10, 2017 in the County of Montgomery, aforesaid, and State of Ohio*, with purpose to defraud, or knowing that she was facilitating a fraud, did utter, or possess with purpose to utter, any writing, to-wit: CHECK(S), which she knew to have been forged; contrary to the form of the statute (in violation of Section 2913.31(A)(3) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

THIRD COUNT:

AND the grand jurors of this County, in the name and by the authority of the State of Ohio, upon their oaths, do find and present that **JENNIFER SELHORST AKA: JENNIFER WOODWARD, BETWEEN THE DATES OF AUGUST 16, 2016 THROUGH FEBRUARY 17, 2017** in the County of Montgomery, aforesaid, and State of Ohio, with purpose to deprive the owner, to-wit: JOHN SULLIVAN of property or services, did knowingly and without the consent of the owner or person authorized to give consent, obtain or exert control over said owner's property or services, having a value of One Thousand Dollars (\$1,000.00) or more but less than \$7,500.00; contrary to the form of the statute (in violation of Section 2913.02(A)(1) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

FOURTH COUNT:

AND the grand jurors of this County, in the name and by the authority of the State of Ohio, upon their oaths, do find and present that **JENNIFER SELHORST AKA: JENNIFER WOODWARD, BETWEEN THE DATES OF AUGUST 16, 2016 THROUGH FEBRUARY 17, 2017** in the County of Montgomery, aforesaid, and State of Ohio, with purpose to deprive the owner, to-wit: JOHN SULLIVAN of property or services, did knowingly and beyond the scope of the express or implied consent of the owner or person authorized to give consent, obtain or exert control over said owner's property or services, having a value of One Thousand Dollars (\$1,000.00) or more but less than \$7,500; contrary to the form of the statute (in violation of Section 2913.02(A)(2) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

FIFTH COUNT:

AND the grand jurors of this County, in the name and by the authority of the State of Ohio, upon their oaths, do find and present that: **JENNIFER SELHORST AKA: JENNIFER WOODWARD, BETWEEN THE DATES OF JANUARY 10, 2017 THROUGH FEBRUARY 17, 2017** in the County of Montgomery, aforesaid, and State of Ohio, with purpose to defraud, did obtain property or services, by the use of a credit card, in one or more transactions, knowing or having reasonable cause to believe that the card had expired or

been revoked, or was obtained, was retained, or was being used in violation of law; the value of said property or services being less than One Thousand Dollars (\$1,000); contrary to the form of the statute (in violation of Section 2913.21(B)(2) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.
